Accessibility statement for Key management of Spatial data services

Traficom strives to guarantee the accessibility of the e-service in compliance with <u>the Act on the</u> <u>Provision of Digital Services (306/2019)</u>.

This accessibility statement applies to the application Key management of Spatial data services.

1.1 Website accessibility status

1.1.1 Compliance status

The service is partially compliant with the requirements of the Web Content Accessibility Guidelines (WCAG) 2.1 level AA. The non-compliances are listed below.

1.1.2 Non-accessible content

The content listed below is non-accessible for the following reasons: Non-compliance with the Act on the Provision of Digital Services (306/2019)

1.1.2.1 Visuality

- The service modal dialogues are not fully readable when text is resized to 200 per cent. (WCAG 1.4.4)
- The service modal dialogues are not correctly scaled to a screen with a width of 320 CSS pixels and a height of 256 CSS pixels. (WCAG 1.4.10)

1.1.2.2 Structure

- The logo in the footer is hidden from screen readers. (WCAG 1.1.1)
- The row titles in a table are not programmatically determined. (WCAG 1.3.1)
- The service includes several identically named "Edit" buttons. When using a screen reader, it is not always clear which data can be edited by clicking on the button. (WCAG 2.4.6)
- Screen reader users are not given an indication that a table can be sorted. (WCAG 2.4.6, 4.1.2)
- There are deficiencies in the programmatic labelling of certain lists. (WCAG 1.3.1)

1.1.2.3 Navigation

• The service is a so-called one-page application in which the screen reader user does not receive information about the transition to a new screen and changes in content. The focus also does not move to the start of new content. (WCAG 2.4.3, 4.1.3)

1.1.2.4 Form elements

- Forms sometimes use passive Continue buttons to indicate that mandatory information has not been filled in. (WCAG 1.3.1, 3.3.1)
- There are deficiencies in the markings of mandatory fields. (WCAG 3.3.2)
