# **Key management of Spatial data services**

#### 1 Terms of use

Key management of Spatial data services (hereinafter referred to as the "key management service") is a service maintained and provided by the Finnish Transport and Communications Agency. The service enables users to access the below-mentioned content provided by the Finnish Transport and Communications Agency, namely API services for spatial datasets, through an API key.

The use of the key management service is subject to the following terms of use, which the user must read carefully before using the service. By using the key management service, the user acknowledges that they have read and accepted these terms, which shall be binding upon both the user and the organisation utilising the content. The use of the key management service is prohibited if the user does not accept these terms or any part of them. The Finnish Transport and Communications Agency may modify these terms of use at any time. Changes take effect immediately upon implementation.

# 2 Liability of the Finnish Transport and Communications Agency

The Finnish Transport and Communications Agency provides the key management service as described in these terms of use. The service is, in principle, available seven days a week.

The key management service and the content accessible through it are provided "as is." The user accesses and uses the service at their own risk. The Finnish Transport and Communications Agency does not guarantee uninterrupted, timely, or error-free operation of the service, nor is it liable for interruptions caused by technical faults, maintenance, installation work or communication disruptions, or for any resultant alteration or loss of data or other information.

The Finnish Transport and Communications Agency may disable the key management service or parts of it due to maintenance, updates, technical issues or other reasons. The Agency may also at any time modify the key management service or the content accessible with the help of the service in full or in part, restrict access, or discontinue the service without prior notice to users.

The Finnish Transport and Communications Agency will, where possible, provide users with advance notice of changes or service interruptions via the service website or by other appropriate means. Changes take effect immediately upon implementation.

The Finnish Transport and Communications Agency accepts no liability for any direct or indirect damages resulting from the use of, or inability to use, the key management service or the content accessible through it.

#### 3 User responsibility

Users are required to use the key management service and its accessible content in accordance with these terms of use, the purpose of use they declare, and applicable laws and regulations.

Any activity that disrupts the operation of the key management service—such as large-scale retrieval of data accessible through the service using another application, or sharing API keys with third parties—is prohibited. If content

accessible via the key management service is used in a manner that deviates from the declared purpose or disrupts the service, access may be completely revoked for the relevant user or organisation.

Users are fully liable for any damages caused to the Finnish Transport and Communications Agency, other users or third parties resulting from their use of the key management service or the content accessed through it.

### 4 Intellectual property rights

All rights related to the key management service, including copyrights and other intellectual property rights of the content accessible through it, belong to the Finnish Transport and Communications Agency. Users are not permitted to make the accessed content or any maps or materials created using the content publicly available by distributing, presenting or displaying them, nor to store or reproduce them without prior written permission from the Agency.

Notwithstanding the foregoing, users are permitted to use the content accessed through the key management service for preparatory work related to a statutory permit process.

Users are responsible for ensuring that content obtained through the service is destroyed once its intended purpose has concluded. This obligation also applies to content shared with third parties.

#### 5 Service fees

The key management service and the content accessible through it are provided free of charge. The use of the service requires an organisation to register using strong Suomi.fi identification. To access the content, the organisation must generate an API key.

#### 6 Available spatial datasets

The API key generated through the key management service allows access to the following spatial datasets:

- Status of offshore wind power projects (WMS interface)
- Status of offshore wind power projects (WFS interface)

## 7 Applicable legislation and dispute resolution

The use of the key management service and the content accessible through it is governed by Finnish law. Any disputes arising from the use of the service are primarily resolved through negotiations between the Finnish Transport and Communications Agency and the user. If a dispute cannot be resolved through negotiation, it will be settled in the first instance by the District Court of Helsinki.
